WHEREAS in virtue of a Judge's Order made on the 07th day of August 2025 before Honourable M. I. A. Neerooa, Judge; Upon application of Mr T. Koenig, Senior Attorney, for applicant and after considering the praecipe and affidavit filed in support of the application both dated 06 August 2025, together the documents thereto attached and being satisfied that the matter is so urgent as to require the immediate intervention of an Honourable Judge in Chambers before notice of the application is served upon the respondents and co - respondents;

IT IS HEREBY ORDERED that an interim order in the nature of an injunction BE AND SAME IS ISSUED;

- (i) Restraining and prohibiting the Respondent no. 1 from undertaking any inspection pursuant to the mandate given to him by the Respondent no. 2 as set out in the Proclamation;
- (ii) Restraining and prohibiting the Respondent no. 2 from appointing and mandating any inspector to undertake any investigation which mandate exceeds or is otherwise in breach of Part XV of the Companies Act; and
- (iii) Restraining the Respondents from doing any acts or omissions to give effect to the mandate as presently couched in the Proclamation in furtherance to any inspection.

IT IS FURTHER ORDERED THAT the above interim order DO remain in force until Wednesday 13 August 2025 at 10.00 hours, when the above-named respondents and co – respondents, BE AND THEY ARE ORDERED to appear before the Honourable M.I.A.Neerooa, Judge sitting in Chambers to show cause why the above interim order should not be enlarged, or discharged, or made interlocutory, or otherwise dealt with after hearing parties.

IT IS ALSO ORDERED THAT the above interim order in the nature of an injunction, BE AND SAME IS ISSUED at applicant's own risks and perils, and upon applicant's undertaking, through its Attorney to abide by any order which the Court or Judge may thereafter make as to damages to the respondents and co - respondents by the granting of this interim order in the nature of an injunction.
